Law in London Lecture: Labor and Employment Law

Russell joined Pattinson & Brewer to work with a team dedicated to representing working people and with a successful track record of dealing with labour law and industrial relations.

Russell is currently representing employees who have taken matters including unfair dismissal, unlawful deduction of wages, TUPE and discrimination to Employment Tribunals to challenge their employers.

Russell has also handled successful discrimination and equal pay claims on behalf of working people in the various courts and tribunals up to the Court of Appeal and Supreme Court.

He has successfully acted for senior professionals with civil court claims for equal pay and high value breach of contract claims. He has represented Construction Industry Scheme workers who had been given sham self-employment contracts, winning in the Employment Tribunal and confirming their employee status.

Russell has supported a union-funded campaign against unpaid internships and helped an intern who had done 3 months' unpaid work secure full payment for every hour worked in a claim against a major employer represented by city law firm.

He has a particular interest in challenging unlawfully unpaid or underpaid work and casualisation and is currently researching potential claims for employees on zero hour and minimum guaranteed hour contracts.

Russell trained at Leigh Day after gaining a Distinction in the LPC and graduating from University College London. He is a member of Industrial Law Society, Discrimination Law Association and the Employment Lawyers Association.

In his free time, Russell has spent time as a volunteer in a fishing community in Senegal and supports the current campaign against illegal pirate fishing in West Africa. He also enjoys spending time with his family and, in his more energetic moments, he loves surfing.

Greg Powell, Managing Partner of Powell Spencer and Partners Solicitors, specializes in serious crime, civil liberties and terrorism. Having read Law at the London School of Economics and Psychology at Birkbeck College, Greg trained with WH Thompson and qualified as a Solicitor in 1973. He later became a founding partner at Powell Spencer in 1977.

Powell has successfully represented a diverse range of clients including the family of a Guantanamo Bay detainee, senior political figures in the 'donorgate' and 'cash for honours' affairs and defendants in many other serious criminal prosecutions.

Powell has an impressive record of clients acquitted of murder (9 out of the last 12). Often approached to represent cases of public interest, Greg has successfully defended the mother who faced a jail sentence as a result of allegedly lying about her address on the school application for her son, a case that raised the interesting issue of 'other intangible property!'

A past president of the London Criminal Courts Solicitors Association (LCCSA), Powell has been both Criminal Law Legal Aid Lawyer of the Year and a 'Times Lawyer of the Week.'

After a decade of involvement in opposing Price Competitive Tendering and the impoverishment of legal aid funding, Powell continues to be engaged in the campaign against legal aid cuts.

Powell once delivered a talk called 'The Importance of Poetry to Criminal Lawyers', which reflected his keen interest in poetry. His first book of poetry was published, 'In Love's Shawl.'
