Note 1: New or Revised Course - see description for detailed information.

Note 2: Limited enrollment offering; may be dropped only during first 5 days of semester.

Students are not permitted to drop the course at any time after the last day of the fall, spring or summer registration period. Clinics and externships are exempt from the upper class grading curve.

Note 11: See Academic Handbook E 4 (a-f) regarding eligibility for academic credit. Any credit given will be on pass/fail basis only. Students eligible to receive 3 credits may register for 2 hours in Fall and 1 hour in spring or 1 hour in fall and 2 hours in spring. Students eligible to receive 2 credits may register for 2 credits in either fall or spring or 1 credit each semester. Students eligible to receive 1 credit may register in either fall or spring.

Note 12: Students may earn up to two fully graded credit hours for independent research under faculty supervision. Satisfactory completion of a two credit independent research project may satisfy the writing requirement provided that the project satisfies the requirements of Academic Rule A(3)(b). LAW 997 only - students earning two credits must register for one credit each semester.

Note 13: Does not meet writing requirement

Note 14: This course meets the upper class Administrative Law or Statutory/Legislative Course requirement for 2L or 3L students enrolled in the course. Review the course description for further information regarding compliance with this requirement.

Note 15: This course satisfies ABA Standard 303(a)(3) which requires all College of Law students to satisfactorily complete one or more experiential course(s) totaling at least six credit hours.

Note 16: This is a one semester clinic. Students must register for 6 credits.

Note 17: This is a year-long clinic. Students must enroll for 6 credits in the Fall and 6 credits in the Spring.

Note 18: All students who accept registration in the Criminal Defense Clinic must be aware that you will be required to attend a four hour clinic training session prior to the official start of the Spring Semester. The training session will occur on....The training session will cover office/administrative aspects of client representation as part of the Criminal Defense Clinic.

Note 19: This is a semester long clinic for 3 credits. Students who have not previously taken a clinic or externship will be given priority in registration over students who have previously enrolled in a clinic or externship.

Note 20: Enrollment for the 2018 Spring semester is open only to those students who enrolled in the Fall 2017 semester. Students who earned one credit in the Fall should register for two credits in the Spring, and students who earned two credits in the Fall should register for one credit in the Spring.

Note 21: Only open to students who have completed the basic clinic course in this specialty area. Enrollment is at the discretion of faculty member and is very limited. Variable credits between 1 and 4, as determined by faculty instructor before start of the semester.

Note 22: 2 hours fall, 2 hours spring; must enroll both semesters (no enrollment permitted for Spring if course was not completed in Fall); will receive grade at end of each semester. Must also enroll in two credit graded externship placement seminar class. Required to work 8 hours/week to receive two additional placement credits and 12 hours/week to receive three additional placement credits. Instructor permission required for registration.

Note 24: This course meets the upperclass Professional Responsibility requirement.

Note 25: Students will earn one credit. This course begins with meetings in November. During late December and early January, students will visit Vietnam. The final meeting and paper will be due in February.

Note 27: Enrollment is limited to students who attend the first class meeting. Classes will meet for 8 weeks on the following days: 1/18, 1/25, 2/1, 2/8, 2/15, 2/22, 3/1 and 3/8. Cross-listed with Whitman School of Management (FIN 827).

Note 28: 3 hours Fall, 3 hours Spring, must enroll both semesters, will receive grade at end of academic year.

Note 29: Required course for JD/MPA students. Cross listed with PAI 751.

Note 30: Meets with PAI 730-M011 and ECS 700-M001.

Note 31: Limited emphasis on Supreme Court and Federal District Court practice in New York.

Note 32: Dates: February 29, 2016 - May 20, 2016. Students must be selected by Pro Bono Scholars Program and NYS Unified Court System

Note 33: Students must register for Pro Bono Scholars Program Seminar

Note 34: Students must register for Pro Bono Scholars Program Externship

Note 35: Students will earn one credit. The grading will be based on a 8-10 page paper researched before, during, and after the trip to South Africa. There will be two one-hour class sessions scheduled before the trip and two one-hour class sessions scheduled after the trip. Applications for this course must be completed and approved before registration.

Note 36: 2-3 hours fall, 2-3 hours spring; must enroll both semesters; will receive grade at end of each semester. Must also enroll in two credit graded externship placement seminar class. Required to work 8 hours/week to receive two additional placement credits and 12 hours/week to receive three additional placement credits. Instructor permission required for registration.

Note 37: Students who completed NYEx in Fall 2017 are eligible to register for one credit of LAW 920, instead of two.

Note 38: Course will not meet every week. Schedule will be disseminated by instructor.

Note 39: Course will be offered simultaneously to students in D.C., NYC, and Syracuse; the course will be live in one location. It is offered two weekends in a row (two Friday evenings and two Saturday mornings).

Dates and times: Friday, April 6 5:00-7:00 pm; Saturday, April 7 9:00 am-1:00 pm; Friday, April 13 5:00-7:00 pm; Saturday, April 14 9:00 am-1:00 pm.

Note 40: Travel to Switzerland and Liechtenstein over spring break 2018 to gain exposure to the foundational principles of international tax law. Two weekend lectures (dates TBD, streamed online for non-SU students), plus travel to Europe for 10 days over spring break. Class size is limited to 30 students. Students who enroll in this course must participate in both the Syracuse and European portions of the program. Any LL.M. student, second- year J.D. law student, or third-year J.D. law in good academic standing may enroll. Any SU graduate student, subject to home academic department and College of Law approvals, may enroll.

Note 41: Students can choose either to (i) write a research paper that meets the writing requirement; or (ii) write a series of shorter papers that do not satisfy the writing requirement. Other course requirements will need to be fulfilled regardless of writing option selected by student.

Note 42: This course will NOT be offered remotely.

Note 43: 2 credit course with 1 credit option. In order to register for the one credit option, student must meet with Kim Wolf Price, Director of Externship Programs, prior to credit adjustment.

Note 44: The course frames its study of International Law in terms of global human rights issues and challenges.
