Children's Rights & Family Law Clinic (CRC), Syracuse University College of Law, Syracuse, NY

The Children's Rights and Family Law Clinic (CRC) is seeking law students for a Summer 2018 position supported by an alumni donation. The focus of the position will be on children who are directly and indirectly affected by the issues handled in the clinic over the summer. The CRC represents families and children providing services in a variety of areas, including but not limited to custody and visitation, child and spousal support, domestic violence, matrimonial matters, adoptions and other ancillary matters such as immigration issues as it relates to the family legal issue.

Applicant Qualifications:

- Rising 2L or 3L law student at Syracuse University College of Law
- Strong research and writing skills
- Good oral communication and organizational skills
- Interest in family law, elder law, and/or other public interest law
- Previous experience with a law school clinic preferred

Fall 2018 OCI (On-Campus Interview) and Resume Collect Program

- Invites rising 2Ls and 3Ls to apply to and interview for employers hiring for summer 2019 positions and post-graduate opportunities.
- Students may view and apply to Fall OCI postings via Symplicity starting on **June 27**th under the "Fall 2018 OCI & Resume Collect" Session
 - Note: you will not see participating employers until June 27th; employers are added on a rolling basis throughout the summer/fall.
- Employers will conduct interviews at Dineen Hall (Suite 214, Career Services) or conduct off-site / phone or Skype interviews.
- Each posting will have a unique student deadline. Review postings carefully and keep track of those opportunities that interest you.
- Check your SYR email throughout the summer!

Employers add summer and post-graduation opportunities to Symplicity on a rolling basis. Be sure to regularly log into your account and click on the "Jobs & Resume Collection" tab and on "CSM Jobs" and sort by date posted, location, employer, etc. to see the most recent postings.

For Rising 2Ls (class of 2020):

Roscoe Trimmier Jr. Diversity Scholarship (Ropes & Gray)

To promote inclusion and diversity within the legal profession, Ropes & Gray created the Roscoe Trimmier Jr. Diversity Scholarship. Mr. Trimmier was the firm's first African American partner and a leader of the firm's inclusion efforts.

The Award

This scholarship provides a \$25,000* award to five outstanding second-year law students to offset the expenses of their legal education, and includes a **paid summer associate position** following completion of the second year of law school. The funds will be paid out half upon completion of the summer program, and half upon starting as a full-time associate at the firm. The scholarship will be awarded to applicants who exemplify the accomplishment, leadership and dedication that were the hallmarks of Mr. Trimmier's life, and who are members of populations historically underrepresented in the legal profession.

Criteria

In addition to meeting the rigorous academic and hiring criteria of Ropes & Gray's entry-level recruiting program, successful applicants for the scholarship must show:

- Demonstrated leadership ability
- Genuine interest in Ropes & Gray's practice
- The personal statement that is part of the application process should address the applicant's qualifications for the scholarship, including, potentially, a description of the applicant's leadership qualities, exceptional contributions to community and commitment to the practice of law.

Eligibility requirements

- Outstanding undergraduate and law school academic achievement
- Member of a historically underrepresented group in the legal profession
- 2L, enrolled in an ABA-accredited law school
- U.S. citizen or authorized to work in the United States
- The application process for the summer of 2019 will be open from June 1 through August 31, 2018.

Clerkship Updates

Main Supreme Judicial Court (Portland, Maine), Law Clerk – Deadline Aug. 3 2018

NY State Supreme Court, Appellate Division, Fourth Dept. (Rochester) – Deadline Oct. 1 2018

Some NJ judges are still hiring! The Administrative Offices for the NJ Judiciary has provided <u>a</u> <u>list of judges seeking a 2018-2019 law clerk</u>. **Look for the judges without an asterisk.**

Steps:

1. Find a judge without an asterisk. Call their chambers and confirm that the judge is still seeking applications for a 2018-2019 term law clerk. (Some may be in the interviewing/final stages.)

2. If the judge is still seeking applications, ask the preferred materials and the best way to submit your application. (Most will say US postal mail.)

2Ls and 3Ls: Post-Grad Federal Clerkship Diversity Initiative (for clerkships beginning in 2019)

In connection with *Just The Beginning-A Pipeline Organization's Share the Wealth Judicial Clerkship Program*, six federal judges will be conducting a round of interviews to fill 2019-2020 clerkship positions in their chambers. The *Share the Wealth Judicial Law Clerk Program* is a referral program run by judges who feel that it is of the upmost importance to encourage more minorities to compete for federal judicial clerkships. The application deadline is Saturday, July 21, 2018, at 5:00 pm EST.
